The sample LSID-19-1644 01317533 was found to not conform to the manufacturer submitted benchmark sample and was analyzed in duplicate to confirm the original scan result, which is our laboratory protocol. 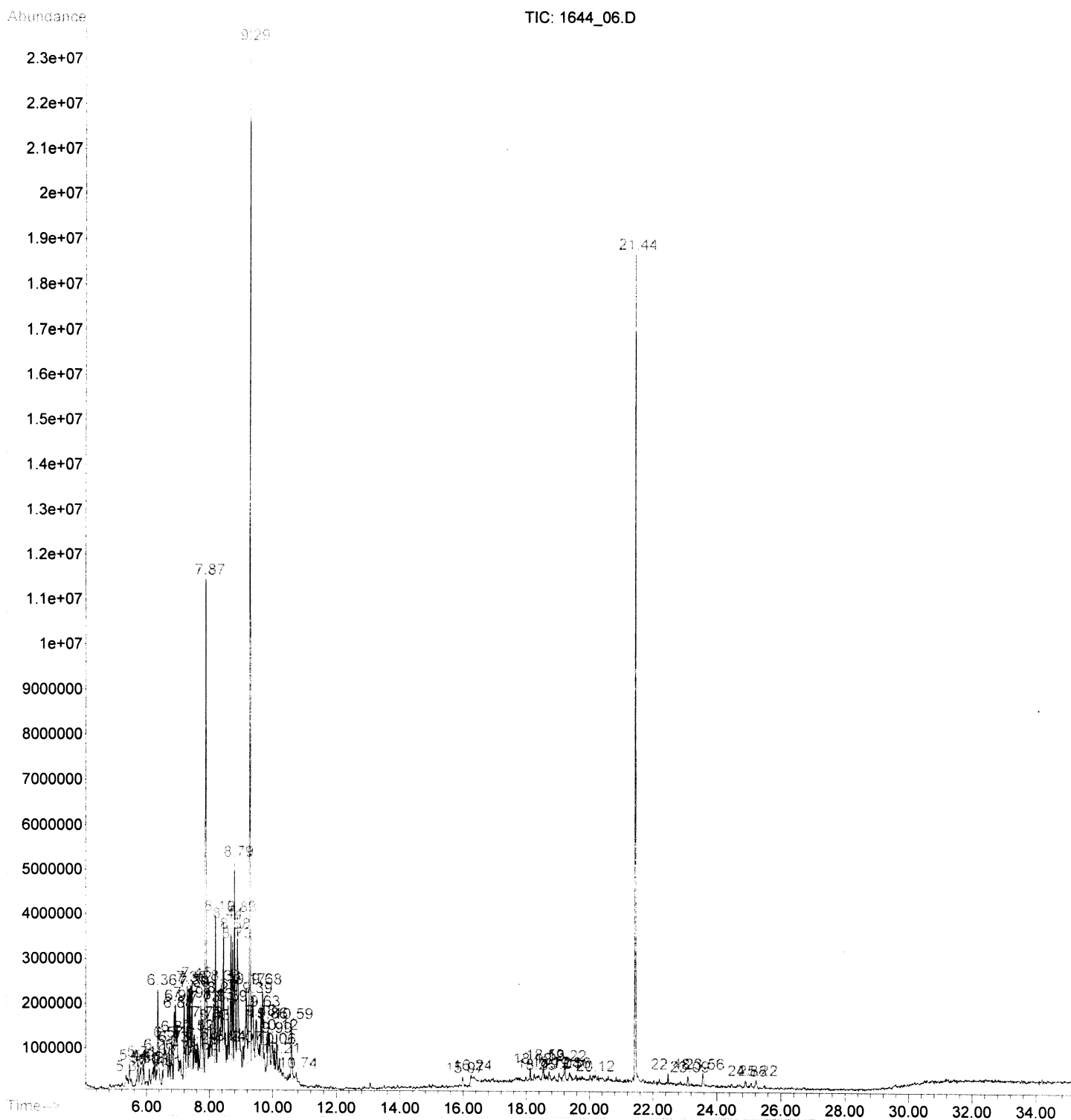

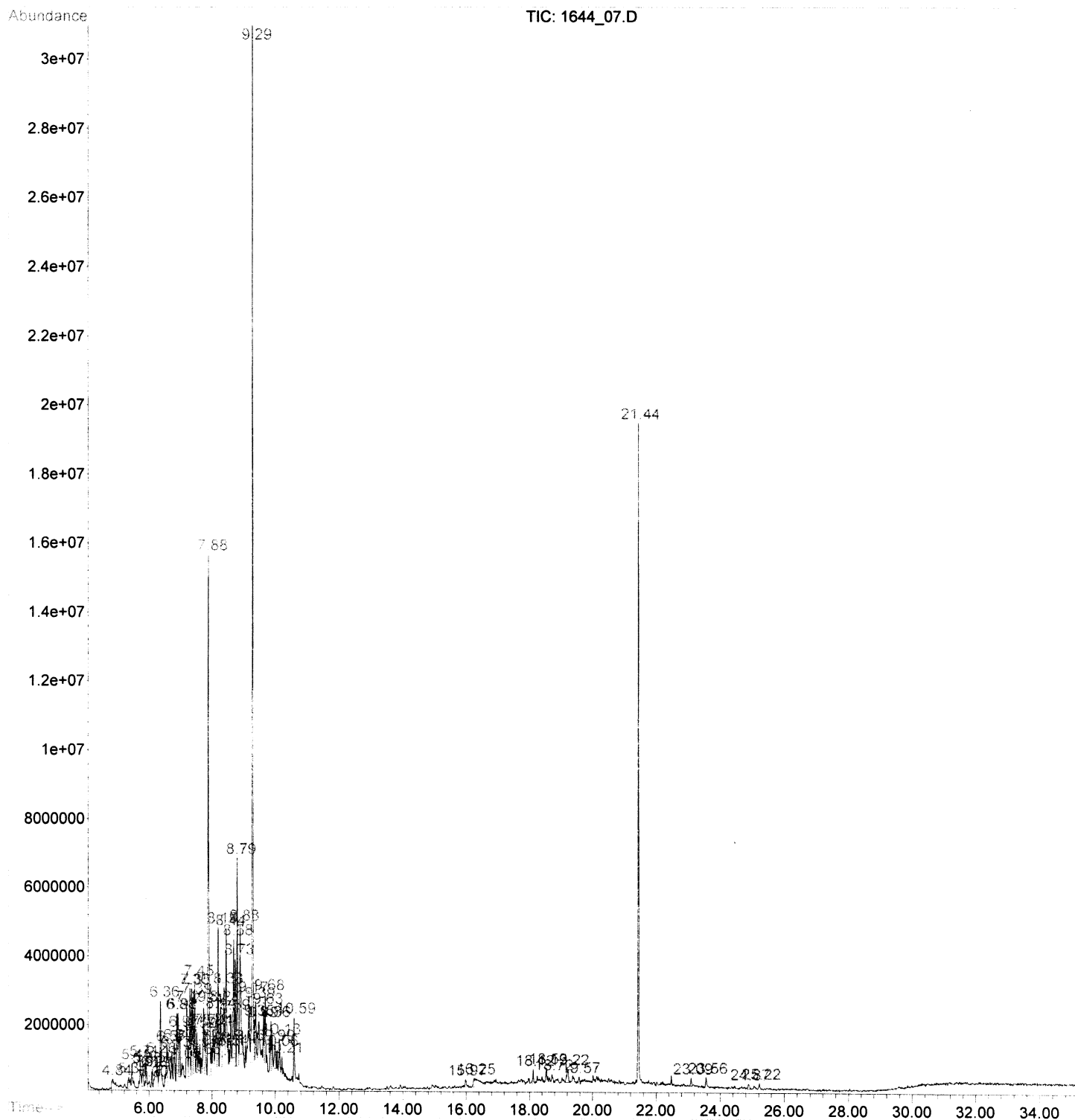

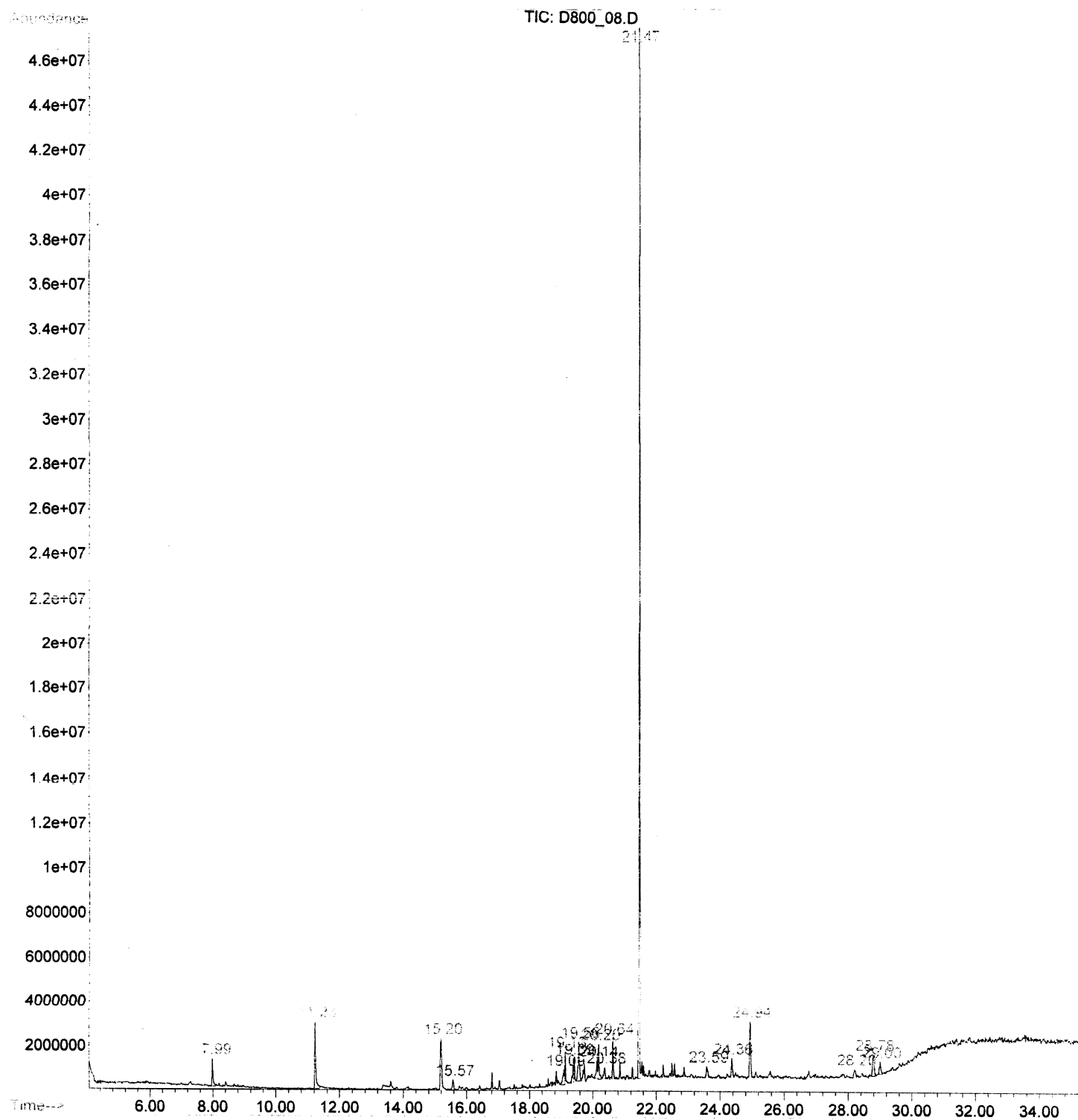
